**What-**

- **Context:** Hong Kong's heat waves cause approximately 170 deaths annually, which are preventable through coordinated heat health action plans.

Local heat health action plans involve multiples sectors of government to create. A high level task must be convened to help people understand their risks and take measures to acquire means to stay cool and well hydrated in a heat wave. Medical providers play a role as do weather authorities, social agencies, housing agencies, environment, leisure, schools etc.

- **Key Objectives:** Empower communities, undertake multisectoral action, integrate primary medical care with essential public health functions to make Hong Kong's vulnerable more protected from health harms from heat waves.

**Workshop Sessions**

**Session 1: Problem Consensus (Feb 10)**

- **Objectives:**
  1. Understand the social epidemiology of excess heat wave deaths.
  2. Assess evidence on future trends in excess heat deaths in Hong Kong.
  3. Understand the role of heat health action plans (HHAPs) in Hong Kong.
- **Activities:**
  - Core reading about heat deaths in Hong Kong
  - Lecture on epidemiology of excess heat.
  - Group formation and vision sharing.
  - Group discussion on Hong Kong's current measures and housing conditions.

**Session 2: Coming Together to Co-design Strategy (Feb 24)**

- **Objectives:**
  1. Assess the policy landscape.
  2. Map stakeholders and prioritize them.
  3. Develop strategic engagement plans.
- **Activities:**
  - Homework on core reading (Brinkerhoff and Crosby).
  - Lecture on implementation science of policy changes.
  - Exercises on stakeholder mapping and creating a GANTT chart for engagement.

### **Session 3: Accountability (March 10)**

- **Objectives:**
  1. Apply skills to policy strategies.
  2. Design accountability into policy strategy.
  3. Begin executing a policy advocacy strategy.
- **Activities:**
  - Core reading (Kania and Kramer).
  - Lecture on collective impact.
  - Exercises on looking inward, outward, and ahead.
  - Budget planning for backbone organization (Group)

### **Session 4: Convene High-Level Intersectoral Stakeholders (March 17)**

### **Final Project. (INDIVIDUAL)**
